Over 600 SoberRides® Provided on St. Patrick's Day in Greater Washington

WRAP's *SoberRide* program provided a record 606 free cab rides home to would-be drunk drivers this St. Patrick's Day.

The 2012 St. Patty's Day *SoberRide* program began on March 17, 2012 (St. Patrick's Day) and continued until 6:00 am the following day as a way to keep local roads safe from impaired drivers during this traditionally high-risk holiday.

"For *SoberRide's* hours of operation this St. Patrick's Day, this translates into the removal of a would-be drunk driver from Greater Washington's roadways every 71-seconds," said Wayne Miller, Chairman of WRAP's *SoberRide* Committee.

During this 12-hour period, Washington-metropolitan area residents celebrating with alcohol could call the toll-free *SoberRide* phone number 1-800-200-TAXI and be afforded a no-cost (up to a \$30 fare), safe way home. (AT&T wireless customers could dial #-TAXI for the same service.)

This March's record ridership for WRAP's St. Patrick's Day *SoberRide* program broke the then record of 603 free cab rides home provided during St. Patrick's Day 2007 (as well as last year's St. Pat's ridership of 547).

Local taxicab companies throughout the Washington-metropolitan area provide this no-cost service to local residents age 21 and older who otherwise may have attempted to drive home after drinking.

SoberRide was offered in the District of Columbia; throughout the Maryland counties of Montgomery and Prince George's; and throughout the Northern Virginia counties of Arlington, Fairfax, (eastern) Loudoun and Prince William.

Sponsors of this year's St. Patrick's Day *SoberRide* offering included Anheuser-Busch, AT&T, Diageo,

20th Anniversary Event Honors Washington-Metro Teens For Fighting Underage Drinking

Calling it a 20th-annual recognition of high school students "doing the right thing," WRAP awarded three Washington-metropolitan area high school student groups with honors this spring and for their efforts in fighting underage drinking.

WRAP's GEICO Student Awards, now in their 20th year, were presented by the non-profit organization along with its partner GEICO to Washington-metropolitan area

high school student groups promoting alcohol and drug-free lifestyles to their peers. The popular awards were judged by a panel of area substance abuse prevention professionals including representatives from traffic safety organizations and prevention coalitions.

Student groups were judged on their leadership, effectiveness, innovation and involvement of both the student body and community in their efforts to prevent underage drinking. Activities of the winning groups included a variety of creative initiatives including: developing "contracts" between students and parents regarding the refraining from alcohol and drug use during prom season; organizing candle vigils to honor the lives of those lost during alcohol-related crashes; organizing alcohol-free teen social events and forums; establishing mentoring relationships between high school and intermediate and elementary school students; and participating on town governing bodies.

WRAP Champions Tougher DUI Laws in Virginia

WRAP's fight against both drunk driving and underage drinking in the Washington-metropolitan area takes the nonprofit organization to Annapolis, Richmond and Washington, D.C. in championing public policies aiming to create effective deterrents to both impaired driving and teen drinking. What follows, and due to this newsletter's print schedule, is a summary of WRAP's 2012 legislative highlights in Virginia.

“Virginia’s patience with the more than 29,000 drivers in the state annually convicted of driving under the influence has worn thin,” quoted WRAP in *The Washington Post’s* “Virginia Politics” blog (2-13-12) and of Virginia’s 2012 session of its General Assembly session which adjourned on March 10, 2012. And as usual, it’s a mixed bag this year in Richmond.

In the solidly good news front, anti-drunk driving legislation requiring ignition interlocks for a minimum of six months for all persons convicted of DUI in Virginia (HB 279) captured over 80-percent of Virginia lawmakers vote and was signed into law by Virginia Governor Bob McDonnell (R) on March 7th. In addition and on March 13th, Governor McDonnell signed into law General Assembly-passed legislation allowing underage persons participating in ABC sting operations to legally purchase and or possess alcohol (SB 406) thereby strengthening the enforcement of Virginia’s underage drinking laws. (Both pieces of signed legislation become Virginia law on July 1, 2012.)

Virginia lawmakers this year also sent to Governor McDonnell since signed into law legislation having the community services board provide to Virginia hospitals information about alcohol and substance abuse services for minors (HB 1075)—watered-down legislation which originally proposed the provision of treatment services to minors hospitalized for alcohol poisoning.

In 2010, 274 persons were killed in Virginia in alcohol-related traffic crashes according to the Virginia Department of Motor Vehicles. Despite Virginia’s recent three consecutive year (2008-2010) decrease in alcohol-related traffic fatalities, the Commonwealth today averages an alcohol-related traffic crash every 64-minutes (8,221 in 2010) and three DUI convictions every hour (29,063 in 2010). In addition, in



January 2012, the national Advocates for Highway and Auto Safety (a coalition of insurance, consumer, health, safety and law enforcement organizations) ranked Virginia amongst the lowest of U.S. states for it failing to adopt key traffic safety and impaired driving laws including those concerning open containers and ignition interlocks.

Conversely—and in addition to 2012 proposed measures seeking to have Virginia’s Crime Commission study the efficacy of ignition interlocks for all DUI offenders (HJ 13), allow the internet advertising of “happy hour” versus the current one-sign limit restriction on the same (HB 470 – bill stricken by patron) and allow exemplary damages for injury or death resulting from a high-BAC (.15+ BAC) (HB 680)—the following bills were killed and or otherwise died this session in Virginia:

- HB 49 & SB 182—which sought to mandate a minimum of one year incarceration for those convicted of DUI manslaughter in the state;
- SB 208—which sought to lengthen Virginia’s administrative license revocation period for a DUI from seven to 60 days;
- HB 962—which sought to mandate a minimum of three years incarceration for those convicted of DUI maiming in the state;
- SB 289—which sought to disallow open containers of alcohol in the passenger areas of motor vehicles;
- HB 957—which sought to extend Virginia’s “zero-tolerance” (.02 BAC) restriction for DUI offenders for two years;

- HB 1163—which sought to mandate I.D. checks for persons believed to be underage attempting to purchase alcohol;
- HB 747—which sought to destroy juvenile records for possession of alcohol not at 19 (current) but at 21 years of age;
- SB 501—which sought to convert the Virginia Alcohol Safety Action Program (VASAP) from a legislative agency to that under Virginia’s Criminal Justice Services Board.

The aforementioned in no way reflects the totality of alcohol and or DUI-related legislation introduced in Virginia this year but does represent a spectrum of those core bills. WRAP’s role in attempting to advance those aforementioned and other anti-drunk driving legislation in Richmond this year and where WRAP has a supporting position included the organization: providing numerous legislative committees with both testimony and substitute bill language; routinely meeting with legislative branch leadership; routinely meeting with both Senate and House members including bills’ chief patrons; providing resource information; and building public support for legislation via WRAP’s regularly-issued *Legislative Alerts*.

The *Richmond Times-Dispatch*, in its April 10, 2012 editorial, “Drunk Driving: Locked,” touted WRAP’s leadership in Richmond this year hailing the nonprofit organization as “an unsurpassed advocate for sober driving.” ■

Over 2,000 Use WRAP's Holiday SoberRide®

Over 2,000 persons in the Washington-metropolitan area used WRAP's free cab ride service, *SoberRide*, this recent holiday season as opposed to possibly driving home drunk.

"For its hours of operation, this level of ridership translates into *SoberRide* removing a would-be drunk driver from Greater Washington's roadways every four minutes this holiday season," said Kurt Gregory Erickson, WRAP's President.

WRAP's winter holiday *SoberRide* offering—which concluded on New Year's Day 2012 after kicking-off and running nightly since December 16, 2011—provided 2,032 total, free cabs rides to local residents age 21 and older who otherwise may have attempted to drive home after drinking.

Nearly 400 (396) persons utilized the Washington-metropolitan area service on New Year's Eve, alone.

WRAP's 2011 holiday *SoberRide* program operated between 10:00 pm and 6:00 am each evening for over two weeks as a way to keep local roads safe from impaired drivers during this traditionally high-risk, holiday period. During that period, Washington-metropolitan area residents celebrating with alcohol could call the toll-free *SoberRide* phone number 1-800-200-TAXI and be afforded a no-cost (up to a \$30 fare), safe way home. (AT&T wireless customers could dial #-TAXI for the same service.)

SoberRide was offered in the: District of Columbia; throughout the Maryland counties of Montgomery and Prince George's; and throughout the Northern Virginia counties of Arlington, Fairfax, (eastern) Loudoun and Prince William. In these areas, local taxicab companies provided this no-cost service to local residents age 21 and older who otherwise may have attempted to drive home after drinking.

Checkpoint Strikeforce Campaign Reduces Area DUI Deaths Through Increased Awareness of Enforcement

A marked decrease in alcohol-related traffic deaths in the District of Columbia, Maryland and Virginia combined with drivers from this area having measurably increased awareness of DUI enforcement in these areas appear to be the dividends of the region’s heralded Checkpoint Strikeforce campaign.

While alcohol-impaired-driving fatalities (fatalities in crashes involving a driver or motorcycle rider with a blood alcohol concentration of .08 grams per deciliter or greater) nationally declined by 4.9-percent in 2010 according to the National Highway Traffic Safety Administration, said same drunk driving deaths declined by: 54.5-percent in the District of Columbia; 6.6-percent in

Maryland; and 13.1-percent in Virginia.

In addition, a survey of 800 District of Columbia, Maryland and Virginia drivers in the region conducted immediately following the 2011 Checkpoint Strikeforce campaign (January 2012) with an oversample of 300 male drivers in these areas ages 21-to-35 showed that two-thirds (66-percent) of the traffic safety campaign’s target audience (said 21-35 year old males) were aware of locally conducted sobriety checkpoints and that, in tandem, perceptions of risk of arrest for drunk driving amongst this target audience climbed over the course of the 2011 traffic safety campaign.

Amongst the Checkpoint Strikeforce campaign’s target audience, the January 2012 post-survey also posted: a 13-percent

increase in awareness of anti-DUI media campaigns; drunk drivers recording the largest jump amongst “serious dangers” (versus aggressive and or distracted drivers, traffic congestion, etc.) drivers face; and designating a driver recording the largest jump amongst “behavior” changes (versus abstention, alternative transportation, etc.) respondents would or have taken “as a result of sobriety checkpoints in their area.”

Checkpoint Strikeforce is a research-based, multi-state, zero-tolerance initiative designed to get impaired drivers off our roads using checkpoints and patrols when and where drunk driving is most likely to occur, and to educate the public about the dangers and consequences of drunk driving. The campaign is supported locally by

grants from the District Department of Transportation as well as from both the Maryland Motor Vehicle Administration's Highway Safety Office and the Virginia Department of Motor Vehicles' Highway Safety Office.

WRAP serves as project director of the public education component of the region's Checkpoint Strikeforce campaign.

Encapsulating the five-month, regional campaign to reduce the incidence of drunken driving—and as a means of combining proactive public education and enforcement efforts in order to raise public awareness of drunk driving—WRAP hosted a regional Checkpoint Strikeforce news conference on December 16, 2011 to highlight 'round the clock & 'round the Beltway DUI enforcement efforts conducted during the winter holiday season. That day and alongside the Chiefs of Police of both Fairfax and Montgomery Counties as well as the Assistant Chief for D.C.'s Metropolitan Police Department, WRAP drew attention to the "Drive Sober or Get Pulled Over" themed traffic safety campaign.

SoberRide® Safely Transports Home 465 Halloween Revelers



WRAP's 2011 Halloween *SoberRide* program provided 465 free cab rides home to would-be drunk drivers in the Washington-metropolitan area.

WRAP's most recent Halloween *SoberRide* program began at 10:00 pm on Saturday, October 29, 2011 and continued until 6:00 am the following day as a way to keep local roads safe from impaired drivers during this traditionally high-risk, holiday period. (WRAP's scheduling of its *SoberRide* program on the Saturday night prior to Halloween was purposeful and was in tandem with that weekend's evening's

adult-oriented Halloween events.)

This fall's *SoberRide* ridership eclipsed that for last Halloween (2010) when 461 persons in the Washington-metro area used the anti-drunk driving service.

According to the National Highway Traffic Safety Administration, nearly half (48%) of all U.S. traffic deaths occurring during Halloween are caused by drunk drivers.

During *SoberRide's* eight-hour period this Halloween, area residents ages 21 and older and celebrating with alcohol could call the toll-free *SoberRide* phone number 1-800-200-TAXI and be afforded a no-cost (up to a \$30 fare), safe way home.

AT&T wireless users could call #-TAXI for the same service. Local taxicab companies throughout the Washington-metropolitan area provided this no-cost service to local residents age 21 and older who otherwise may have attempted to drive home after drinking.

Drunk Driving Deaths Increase After Three-Year Decline While DUI Injuries, Crashes and Arrests Decrease in Greater Washington

While the number of local alcohol-related traffic fatalities increased in 2010, drunk driving injuries, crashes and arrests each decreased in Greater Washington according to a report released this year by WRAP.

“2010 recorded the largest number of local drunk driving deaths in four years and is wholly unacceptable,” said WRAP’s President, Kurt Erickson. “This report is a reminder that, unfortunately, Greater Washington’s fight against drunk driving is far from won.”

WRAP’s 19th-annual “How Safe are Our Roads?, A Data Report on the Impact of Drunk Driving on Highway Safety in the Washington Metropolitan Region” was prepared by the Metropolitan Washington Council of Governments (COG) and is viewable on the nonprofit organization’s website at www.wrap.org/highwaysafety11.pdf.

Findings in the 2011 report include:

Fatalities

Local alcohol and or drug-related traffic deaths increased between 2009 and 2010 by 26.37% (91 to 115 respectively). Such negates a previous, three-year consecutive decline in such deaths occurring in the Greater Washington area.

Crashes

Area traffic crashes attributed to alcohol and or drugs decreased by 4.7% between 2009 and 2010 (and from 4,921 to 4,689 such crashes).

Injuries

Local alcohol and or drug-related traffic injuries also decreased by (16.5%) between

to 14,594 such arrests). Such represents the second consecutive year decrease in such arrests being made in the Greater Washington area.


Of the Washington metropolitan area’s 253 total traffic fatalities for 2010, 21.3% of these roadway deaths were alcohol and or drug-related (BAC = .01+). 2010 national statistics (National Highway Traffic Safety Administration) show that 40.6% of total U.S. vehicular fatalities in 2010 were reported as alcohol/drug related (BAC = .01+). The Washington-metropolitan area’s alcohol-related traffic deaths are consistently lower than the national average.

“As all drunk driving incidents are 100-percent preventable, these latest trends are reversible,” said Erickson. “However, to do so, we must resist complacency in combating one of the region’s most frequently committed violent crimes, drunk driving.”


WRAP’s timing in releasing its traffic safety report was in tandem with the recent release of the National Highway Traffic Safety Administration’s (NHTSA) Traffic Safety Facts state reports.

Using NHTSA’s current Blood Alcohol Concentration (BAC) standard of .08+ BAC (which will be reflected in future “How Safe are Our Roads?” reports), of the Washington metropolitan

area’s 253 total traffic fatalities in 2010, over one-quarter (26.1-percent) of these roadway deaths were attributable to alcohol-impaired driving. Comparatively, the percentage of all U.S. vehicular fatalities in 2010 attributable to alcohol-impaired driving was 31.1-percent. ■

In an emotional ceremony in Annapolis on December 7, 2011, Maryland Lieutenant Governor Anthony Brown (D) memorialized the state’s victims of drunk driving while simultaneously calling for safety during what he labeled as one of the

deadliest times of year when it comes to drunk driving.

Noting the fact that the period between Thanksgiving and New Year’s Day is historically that holiday period when the largest number of U.S. alcohol-related

traffic fatalities occurs, Brown reminded Maryland drivers on the need for safety this holiday season.

“By giving voice to those silenced by drunk driving, Maryland Remembers serves as a powerful deterrent to anyone tempted to get behind the wheel after drinking,” said Lt. Governor Brown. “With more than 170 Marylanders killed by drunk drivers last year, our message must be loud and clear as we head into the holiday season, a time when fatalities rise: Don’t drink and drive.”

Emphasizing his plea, a procession of Maryland families each baring photographs of loved ones killed in alcohol-related traffic crashes began what was billed as the state’s eighth-annual “Maryland Remembers” ceremony. Family members each went to the front of the room in the Maryland General Assembly’s Miller Senate Building and solemnly said the name of their victim of drunk driving.

In addition to Lieutenant Governor Brown, other speakers at this annual ceremony hosted by WRAP included Colonel Marcus Brown, Superintendent of the Maryland State Police, Darrell Mobley, Maryland’s Deputy Secretary of Transportation and Casey Brooks whose father, Maryland Transit Authority Police Corporal Courtney G. Brooks, was struck and killed by a drunk driver in Baltimore on December 31, 2007. ■

WRAP Calls For Safety on Super Bowl Sunday

Following the finalization of the teams, site and time, WRAP urged the public to also develop a game plan to prevent drunk driving during this year’s “Super Bowl Sunday.”

During Super Bowl Sunday 2009, 50% (58 of 115) of all U.S. crash fatalities occurred in crashes where drivers or motorcycle riders had blood alcohol concentrations of .08 grams per deciliter or higher according to the National Highway Traffic Safety Administration (NHTSA).

“With half of all U.S. traffic deaths being caused by drunk drivers during Super Bowl Sunday, it’s important to have a game-plan prior to kick-off and to beat this too often deadly opposition,” said Kurt Gregory Erickson, WRAP’s President.

WRAP issued a number of “safe celebrating” tips to prevent drunk driving during “Super Bowl Sunday,” scheduled for February 5, 2012. These tips included:

- **Planning ahead and designate a driver if you’re celebrating with alcohol.**
- **Using alternative transportation like taxi cabs.**
- **Being a responsible host by:**
 - **Not serving anyone who appears to be impaired.**
 - **Serving food with alcohol (high protein foods like meats and cheeses stay in the stomach longer thereby slowing the body’s alcohol absorption rate).**
 - **Using a non-carbonated base in alcoholic punches (the body absorbs alcohol faster when mixed with carbonization).**
 - **Serving non-alcoholic beverages as an option.**
 - **Never serving minors.**
 - **Closing the bar at least an hour before the event’s end.**
 - **Designate a bartender/don’t let guests mix their own drinks.**
- **And never allowing impaired guest to get behind the wheel.**
- **Reporting drunk drivers. (Maryland and Virginia law enforcement professionals both encourage the use of the “#77 feature” on wireless telephones for motorists to report suspected drunk drivers. In D.C., dialing “311” is encouraged for the same.)**
- **Wearing your seatbelt.**

“Wearing a seatbelt may not be widely viewed as a tool in this effort but the wearing of a seatbelt may be your best defense against a drunk driver,” said Kaufmann. “The bottom-line is that the routine wearing of seatbelts is the single most effective measure to reduce crash-related deaths and injuries.” ■

“Today’s awardees represent the front lines in the fight against drunk driving in Greater Washington,” said John O’Donnell, WRAP’s Chairman. “It is only through their commitment in stopping the threat that impaired driving presents to all our friends and families that the Washington-

metropolitan area continues to have a rate of alcohol-related traffic deaths lower than the national average.”

In addition to receiving the Law Enforcement Awards, each of the 2011 WRAP honorees also received a pair of complementary Washington Nationals tickets (courtesy of the Washington Nationals) as well as a \$ 25 prepaid gas card (courtesy of Exxon Mobil). ■

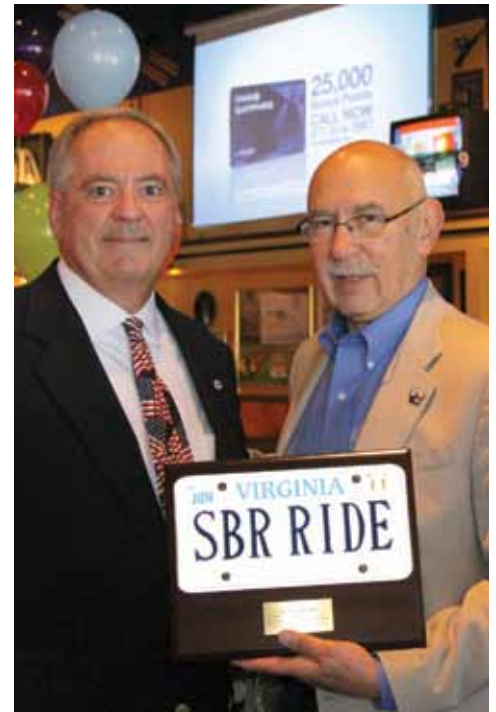
