n the fiscal year which this publication covers (October 1, 2011 through September 30, 2012), the nonprofit Washington Regional Alcohol Program (WRAP) has, again, posted some pretty impressive numbers on the board. Specifically in fiscal year 2012 alone, WRAP highlights include the organization:

- removing 3,318 would-be drunk drivers from Greater Washington's roadways via WRAP's free cab ride service, SoberRide®, including the posting of record ridership for the 2012 St. Patrick's Day campaign when 606 persons in the Washington-metropolitan area used WRAP's SoberRide® service rather than possibly driving home impaired;
- reaching over 7,000 Greater Washington residents with WRAP's innovative health education programs including over 4,300 area high school students with WRAP's multi-media outreach program, Alcohol Awareness for Students;
- celebrating the 20th year of WRAP's esteemed GEICO Student Awards program awarding to-date over \$ 55,000 in prizes to area student organizations promoting alcohol and drug-free lifestyles to their peers;
- successfully helping to lead the District of Columbia's efforts to enact legislation increasing the penalties for DUI in the city and paving the way for the reinstallation of D.C.'s breathalyzer program; and, in Virginia, helping to successfully champion the enactment of legislation requiring proven effective technology for all persons convicted of DUI in that state;
- and spearheading the region's 11th-annual Checkpoint Strikeforce campaign resulting in downward trending alcohol-related traffic fatalities in each the District of Columbia, Maryland and Virginia with each locality outpacing national trends in this same arena.

Collectively, these strategic WRAP achievements are helping to reduce drunk driving deaths in the District of Columbia, Maryland and Virginia. In fact, and using the latest U.S. Department of Transportation figures, while alcohol-related traffic fatalities nationally have declined by 4.9-percent, they declined by over six-percent in Maryland, by over 13-percent in Virginia and by over 54-percent in the District of Columbia.

It is, of course, impressive that this local and lifesaving work is performed by WRAP's just three-person staff. It is astonishing, however, that this same organization and staff spends only 2.8-percent of its total expenses on administration and fundraising.

While 2012 commemorates WRAP's 30th year in fighting drunk driving and underage drinking, we need to make sure that the charity's success doesn't translate into complacency. To that end, I urge you to get and or stay involved with Greater Washington's winning fight against drunk driving.

After all, the life you save may be your own.

Inaugural "Celebrate My Drive" Youth Event





"SoberRide Gives 2,000 Free Trips Over Holiday"

ADVOCACY

VIRGINIA:

"The Washington Regional Alcohol Program rallied for the passage of several DUI bills this session," reported Capital News Service (3-8-12) and regarding WRAP helping to successfully champion legislation during Virginia's 2012 General Assembly and which requires ignition interlocks for a minimum of six months for all persons convicted of DUI in Virginia. The legislation, which captured over 80-percent of Virginia lawmakers' votes, was signed into law by Virginia Governor Bob McDonnell (R) in March 2012. In addition, Governor McDonnell signed into law General Assembly-passed legislation: allowing underage persons participating in ABC sting operations to legally purchase and or possess alcohol thereby strengthening the enforcement of Virginia's underage drinking laws; and having the community services board provide to Virginia hospitals information about alcohol and substance abuse services for minors. WRAP's role in helping to advance the aforementioned and other anti-drunk driving legislation in Richmond in 2012 and where WRAP has a supporting position included the organization: providing numerous legislative committees with both testimony and substitute bill language; routinely meeting with legislative branch leadership; routinely meeting with both Senate and House members including bills' chief patrons; providing resource information; and building public support for legislation via WRAP's regularly-issued Legislative Alerts.

DISTRICT OF COLUMBIA:

"District police could resume breath-testing suspected drunk drivers next month under a D.C. Council bill...that would overhaul the city's troubled breathalyzer program and stiffen standards and punishment for impaired drivers," reported *The Washington Post* (7-10-12) and regarding WRAP successfully championing legislation during the Council of the District of Columbia's 2012 session and which **persons convicted of driving under the influence (DUI) in the city now face the potential of increased** fines, increased jail sentences and mandatory **incarceration if convicted of DUI with a child in the car.**

Enacted as emergency legislation in August 2012 and unanimously passed by the Council of the District of Columbia, the "Comprehensive Impaired Driving Act of 2012" increases the maximum fines and incarceration periods for

all persons convicted of DUI in the District; doubles the mandatory-minimum jail sentences (from five to ten days) for convicted high-blood alcohol concentration (BAC) offenders (.20+ BAC); and creates a minimum five-day jail sentence for persons convicted of DUI whilst transporting a minor.

The District of Columbia's newest DUI law also installs inaugural BAC limits for commercial vehicle operators in the District (.04 BAC) and places oversight of the city's breathalyzer program with the District's independent forensic agency, the Chief Medical Examiner's office, thereby paving the way for the reinstallation of the city's dormant DUI breath-testing program.

MARYLAND:

"Half of all minors killed in alcohol-related traffic crashes in Maryland specifically were occupants of a vehicle driven by a drunk driver," *WTOP News* quoted WRAP (2-23-12) in reporting of 2012 Maryland General Assembly legislation looking to **increase the penalties for persons convicted of DUI while transporting a minor.** While WRAP, in its capacity as Legislative Committee Vice Chairman of the nearly 300member Maryland Impaired Driving Coalition, supported the anti-drunk driving legislation, the bill ultimately failed in Annapolis in 2012.

WRAP's role in attempting to advance the aforementioned and other anti-drunk driving legislation in Annapolis in 2012 and where WRAP has a supporting position included the organization: providing numerous legislative committees with both testimony and substitute bill language; routinely meeting with legislative branch leadership; routinely meeting with both Senate and House members including bills' chief patrons; providing resource information; and building public support for legislation via WRAP's regularly-issued Legislative Alerts.

"How Safe are Our Roads?" Report


- Highway Safety Leadership...In FY 2012, WRAP continued its role as both the Impaired Driving Emphasis Area Team Leader for Maryland's updating of its Strategic Highway Safety Plan as well as on the steering committee for Virginia's similar updating of that state's Strategic Highway Safety Plan.
- DUI Court...As an extension of WRAP's public policy positions supporting "focusing supervision of offenders by judges monitoring compliance with court-ordered sanctions and or treatment," WRAP continued its efforts in FY 2012 and on a workgroup spearheaded by a number of District of Columbia Superior Court Judges to reinstall a formal DUI court in Washington, D.C.
- Featured Presenter...Throughout FY 2012, WRAP served as a featured presenter engaging numerous audiences and forums as diverse as the 2012 Mid-Atlantic DUI Conference in Virginia Beach, the 2011 Military Civilian Transportation Safety Workshop at Fort Eustis, Virginia and The Century Council's 2011 Congressional Stop DUI Caucus event in the Rayburn House Office Building in Washington, D.C.
- WRAP Summer Board Function...In June 2012 and for its voluntary leadership, WRAP conducted its annual "traditionally nontraditional summer Board function" in Greenbelt, Maryland consisting of a U.S. Park Police-orchestrated and unique "wet lab" where the real-life, real-time effects of alcohol on a person's ability to perform even the simplest motor functions (simulating the hazardous effects of driving while under the influence) were showcased. This dynamic event featured a

live demonstration of the effects of alcohol as two outside individuals: consumed multiple drinks under police supervision; submitted to breathalyzer tests as impairment increased; and while under the influence, underwent a battery of sobriety tests administered by U.S. Park Police officers.

• Editorial Nods...The *Richmond Times-Dispatch*, in its April 10, 2012 editorial, "Drunk Driving: Locked," touted WRAP's leadership in Richmond that year hailing the nonprofit organization as "an unsurpassed advocate for sober driving." In addition, WRAP received a kind, national nod to its SoberRide[®] program in the *Huffington Post's* popular blog on May 29, 1012 when the free cab ride service to prevent drunk driving was hailed as an "innovative approach to prevent drunk driving crashes and needless loss of life" by contributor and Columbia University Medical Center Professor Barron Lerner.

NOTES TO FINANCIAL STATEMENTS

NOTE A - Organization and Significant Accounting Policies

Organization

The Washington Regional Alcohol Program, Inc. (the Organization) was incorporated under the laws of the state of Maryland. The Organization is a non-profit-public-private partnership working to prevent drunk driving and underage drinking in the Washington, D.C. metropolitan area. The office is located in McLean, Virginia.

Basis of Presentation

Financial statement presentation follows generally accepted accounting principles. Accordingly, the Organization is required to report information regarding its financial position and activities according to three classes of net assets: unrestricted net assets, temporarily restricted net assets, and permanently restricted net assets. The financial statements are prepared on the accrual basis.

Revenue is generated primarily through public grant programs and private sector contributions. The grant programs are sponsored by federal, state and local governments and reimburse the Organization for labor and administrative costs incurred to conduct programs aimed at reducing alcohol related fatalities and underage drinking. Advertising costs are expensed as incurred.

Income Taxes

The Organization is exempt from federal and state income tax under Section 501(c)(3) of the Internal Revenue Code on all but unrelated business income. The Organization had no unrelated business income during the year ended September 30, 2012. The Organization's tax returns open to examination are the years ended September 30, 2009, 2010 and 2011.

Cash and Cash Equivalents

The Organization considers all highly liquid short-term investments which have an original maturity of three months or less when acquired, to be cash equivalents.

Property and Equipment

Property and equipment are stated at cost. Contributed property and equipment is stated at fair market value on the date of contribution. The Organization capitalizes all acquisitions of property and equipment in excess of \$500. Depreciation and amortization is computed using the straight-line method over the estimated useful lives of the related assets, ranging from 5 to 7 years.

Functional Allocation of Expenses

The costs of providing the various programs and activities have been summarized on a functional basis in the statement of activities. Accordingly, certain costs have been allocated among the programs and supporting services benefited.

Recognition of Donor Restricted Contributions

Support that is restricted by the donor is reported as an increase in unrestricted net assets if the restriction expires in the reporting period in which the support is recognized. All other donor-restricted support is reported as an increase in temporarily restricted net assets depending on the nature of the restriction. When a restriction expires, temporarily restricted net assets are reclassified to unrestricted net assets and reported in the Statement of Activities as net assets released from restrictions.

Use of Estimates

Management uses estimates and assumptions in preparing financial statements in accordance with generally accepted accounting principles. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and reported revenue and expenses. Actual results could vary from the estimates that were assumed in preparing the financial statements.

Concentration of Credit Risk

Cash is maintained at a bank insured by the Federal Deposit Insurance Corporation and is fully insured through December 31, 2012.

Contributed Services

Contributed services to air public service announcements to benefit the Organization's public education programs were received and meet the criteria for recognition in the financial statements during the year ended September 30, 2012. The fair value of the contributed air time, which totaled \$1,098,561 is recognized as an in-kind contribution and a consulting expense in the financial statements. Additionally, in-kind salaries and wages, equipment and supplies of \$43,312 and \$6,510, respectively, are recognized as an in-kind contribution and expense in the financial statements.

NOTE B - Federally Assisted Grant Programs

The Organization participates in a number of federally assisted grant programs. The Organization's federal and state grants are subject to federal and state compliance audits by the grantors or their representatives. Such audits could lead to requests for reimbursements to the grantor agency for expenditures disallowed under the terms of the grant. Based upon prior experience, the Organization believes that such disallowances, if any, would not be significant.

NOTE C - Commitment

The Organization extended its sub-lease of office space under a new agreement through March 31, 2013. The rent is based on the square footage occupied by the Organization, currently 780 square feet at approximately \$26.84 per square foot annually. The rate increases by two and a half percent annually each year over the life of the lease. Annual rentals for periods after September 30, 2012, until the lease expires, are as follows: September 30, 2013 \$15,901

Rent expense for the year amounted to \$ 29,930.

NOTE D - Operating Vulnerability

The Organization is heavily dependent upon government grants and contracts for its operations. If government funds were curtailed it would be necessary to curtail or eliminate several programs. The expectation is that government entities will continue funding may of the programs. In the event one funding source would terminate the relationship with the Organization, management believes sufficient funding exists from other sources to continue the basic program of the Organization.

NOTE E - Retirement Plan

Eligible employees of the Organization are included, on a voluntary basis, in a contributory tax-deferred annuity plan administered by the Organization. Employees satisfy eligibility requirements when they complete one year of service and are at least eighteen years old or older. Contributions by the Organization were \$10,780.

NOTE F - Related Party Transactions

The Organization engaged two firms to provide media consulting services for the Checkpoint Strikeforce Campaign. Certain members of management of these firms are also members of the Organization's Board of Directors. For the year ended September 30, 2012, payments to these firms totaled \$635,035. Amounts due to these firms, included in accounts payable, totaled \$385,944 at September 30, 2012.

The Organization also engaged a company to provide cab rides during the SoberRide Campaign. Certain members of management of this company are also members of the Organization's Board of Directors. For the year ended September 30, 2012, payments to this company totaled \$16,655. At September 30, 2012, \$2,341 is due and included in accounts payable.

One other member of the Organization's board of directors provided services and data to the Organization which totaled \$15,000.

The Organization follows standard procurement procedures for these and all other contracts.

NOTE G - Subsequent Events

Subsequent events have been considered by the Organization and are included in the financial statements through May 7, 2013, the date the financial statements were available for issue.

NOTE H - Line Of Credit

During 2012, the Organization obtained a \$50,000 unsecured line of credit with a local bank. No draws were made on the line of credit and no amounts were outstanding at September 30, 2012.


