# CHAIRMAN'S MESSAGE



he highlights of the lifesaving work performed by the nonprofit Washington Regional Alcohol Program (WRAP) in the fiscal year which this publication covers (October 1, 2012 through September 30, 2013) are many and include the organization:

- removing 2,578 would-be drunk drivers from Greater Washington's roadways via WRAP's free cab ride service, SoberRide®;
- launching WRAP's half cab / half cop car, the "Chooser Cruiser," to deter drunk driving in the Washington-metropolitan area – earning Virginia's prestigious 2013 Governor's Transportation Safety Award for the innovative, public education initiative;
- reaching over 5,500 Greater Washington residents with WRAP's innovative health education programs including nearly 4,200 area high school students with WRAP's multi-media outreach program, Alcohol Awareness for Students;
- celebrating the 21st year of WRAP's esteemed GEICO Student Awards program awarding to-date over \$ 60,000 in prizes to area student organizations promoting alcohol and drug-free lifestyles to their peers;
- successfully championing legislation in Virginia
  which increases the penalties for persons
  repeatedly convicted of drunk driving in the
  Commonwealth; and, in Maryland, supporting
  yet-successful legislation proposing to both
  increase the universe of blood alcohol
  concentration-tested drivers in the state as
  well as increasing the penalties for persons
  convicted of drunk driving while transporting
  a minor;
- and spearheading the region's 12th-annual Checkpoint Strikeforce campaign including introducing the traffic safety campaign's new superhero, Soberman, resulting in downward

trending alcohol-related traffic fatalities in each the District of Columbia, Maryland and Virginia with each locality outpacing national trends in this same arena.

The dividends of these investments in public health and public safety most notably include the marked reduction of highway deaths attributable to drunk driving occurring in the District of Columbia, Maryland and Virginia. Using the latest U.S. Department of Transportation figures (2012), while alcohol-impaired driving fatalities nationally have *increased* by 4.6-percent, they *decreased* by more than a half-percent in Maryland, by five-percent in the District of Columbia and by over seven-percent in Virginia.

In fact and since its founding in 1982 – and in addition to WRAP's popular SoberRide<sup>®</sup> program providing 58,272 free cab rides home to would-be drunk drivers in the Greater Washington area – the number of drunk driving deaths occurring each year in the Washington-metropolitan area has been nearly halved.

As a three-person charitable organization, WRAP has proven to be a more than able steward of the tax-deductible donations it is fortunate enough to receive. In fact and for the fiscal year covered in this publication, WRAP spent only 3.2-percent of its *total* expenses on administration and fundraising.

To those of you already contributing to the local fight against drunk driving and underage drinking, thank you. For those of you not yet involved in this local, lifesaving work, I invite you to join WRAP in its *wiming* fight against drunk driving and teen drinking.

## Moment of Silence






## MARYLAND:





# NOTE A - Organization and Significant Accounting Policies

### Organization

The Washington Regional Alcohol Program, Inc. (the Organization) was incorporated under the laws of the state of Maryland. The Organization is a non-profit-public-private partnership working to prevent drunk driving and underage drinking in the Washington, D.C. metropolitan area.

#### Basis of Presentation

Financial statement presentation follows generally accepted accounting principles. Accordingly, the Organization is required to report information regarding its financial position and activities according to three classes of net assets: unrestricted net assets, temporarily restricted net assets, and permanently restricted net assets. The financial statements are prepared on the accrual basis. Revenue is generated primarily through public grant programs and private sector contributions. The grant programs are sponsored by federal, state and local governments and reimburse the Organization for labor and administrative costs incurred to conduct programs aimed at reducing alcohol related fatalities and underage drinking. Advertising costs are expensed as incurred.

#### Income Taxes

The Organization is exempt from federal and state income tax under Section 501(c)(3) of the Internal Revenue Code on all but unrelated business income. The Organization had no unrelated business income during the year ended September 30, 2013. The Organization's tax returns open to examination are the years ended September 30, 2010, 2011 and 2012.

### Cash and Cash Equivalents

The Organization considers all highly liquid short-term investments which have an original maturity of three months or less when acquired, to be cash equivalents.

#### Property and Equipment

Property and equipment are stated at cost. Contributed property and equipment is stated at fair market value on the date of contribution. The Organization capitalizes all acquisitions of property and equipment in excess of \$500. Depreciation and amortization is computed using the straight-line method over the estimated useful lives of the related assets, ranging from 5 to 7 years.

### Functional Allocation of Expenses

The costs of providing the various programs and activities have been summarized on a functional basis in the statement of activities. Accordingly, certain costs have been allocated among the programs and supporting services benefited.

### Recognition of Donor Restricted Contributions

Support that is restricted by the donor is reported as an increase in unrestricted net assets if the restriction expires in the reporting period in which the support is recognized. All other donor-restricted support is reported as an increase in temporarily restricted net assets depending on the nature of the restriction. When a restriction expires, temporarily restricted net assets are reclassified to unrestricted net assets and reported in the Statement of Activities as net assets released from restrictions.

#### Use of Estimates

Management uses estimates and assumptions in preparing financial statements in accordance with generally accepted accounting principles. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and reported revenue and expenses. Actual results could vary from the estimates that were assumed in preparing the financial statements.

#### Concentration of Credit Risk

Cash is maintained at a bank insured by the Federal Deposit Insurance Corporation up to \$250,000.

#### Contributed Services

Contributed services to air public service announcements to benefit the Organization's public education programs were received and meet the criteria for recognition in the financial statements during the year ended September 30, 2013. The fair value of the contributed air time, which totaled \$1,080,501 is recognized as an in-kind contribution and a consulting expense in the financial statements. Additionally, in-kind salaries and wages, equipment and supplies of \$43,312 and \$6,510, respectively, are recognized as an in-kind contribution and expense in the financial statements.

# NOTE B - Federally Assisted Grant Programs

The Organization participates in a number of federally assisted grant programs. The Organization's federal and state grants are subject to federal and state compliance audits by the grantors or their representatives. Such audits could lead to requests for reimbursements to the grantor agency for expenditures disallowed under the terms of the grant. Based upon prior experience, the Organization believes that such disallowances, if any, would not be significant.

### NOTE C - Commitment

The Organization has a short term sub-lease arrangement of office space through June 30, 2014.

Rent expense for the year amounted to \$ 26,998.

## NOTE D - Operating Vulnerability

The Organization is heavily dependent upon government grants and contracts for its operations. If government funds were curtailed it would be necessary to curtail or eliminate several programs. The expectation is that government entities will continue funding may of the programs. In the event one funding source would terminate the relationship with the Organization, management believes sufficient funding exists from other sources to continue the basic program of the Organization.

## NOTE E - Retirement Plan

Eligible employees of the Organization are included, on a voluntary basis, in a contributory tax-deferred annuity plan administered by the Organization. Employees satisfy eligibility requirements when they complete one year of service and are at least eighteen years old or older. Contributions by the Organization were \$10,780.

## **NOTE F - Related Party Transactions**

The Organization engaged two firms to provide media consulting services for the Checkpoint Strikeforce Campaign. Certain members of management of these firms are also members of the Organization's Board of Directors. For the year ended September 30, 2013, payments to these firms totaled \$364,601. Amounts due to these firms, included in accounts payable, totaled \$133,144 at September 30, 2013.

One other member of the Organization's board of directors provided services and data to the Organization which totaled \$15,000.

Members of the Organization's board of directors provided grants and contributions of \$85,000 to the Organization for the year ended September 30, 2013.

## **NOTE G - Subsequent Events**

Subsequent events have been considered by the Organization and are included in the financial statements through January 24, 2014, the date the financial statements were available for issue.

#### NOTE H - Line Of Credit

The Organization has a \$50,000 unsecured line of credit with a local bank. No draws were made on the line of credit and no amounts were outstanding at September 30, 2013.
